INTENDED USE

ichroma™ CRP is a fluorescence Immunoassay (FIA) for the quantitative determination of CRP in <u>human whole blood/serum/plasma</u>. It is useful as an aid in management and monitoring of autoimmune diseases and infectious processes, such as rheumatoid arthritis.

For in vitro diagnostic use only.

INTRODUCTION

C-reactive protein (CRP) is a protein found in blood; the level of which rises in response to inflammation. CRP is first acutephase protein to be described and is an exquisitely sensitive systemic marker of inflammation and tissue damage. The serum CRP level may rise from a normal level of < 5 mg/L to 500 mg/L during the body's general, nonspecific response to infections and other acute inflammatory conditions. Measurement of CRP concentration has been widely used as a clinical tool for monitoring the status of inflammation, effectiveness of treatment of various infections and autoimmune diseases such as rheumatoid arthritis. And high sensitive CRP (hsCRP) has been suggested that along with serum cholesterol, may be marker of diagnosis in cardiovascular diseases (CVD). And hsCRP is emerging as the strongest and most independent predictive risk factor for CVD.

PRINCIPLE

The test uses a sandwich immunodetection method.

The detector antibodies in buffer bind to antigens in the sample, forming antigen-antibody complexes, and migrate onto nitrocellulose matrix to be captured by the other immobilized-antibodies on a test strip.

More antigens in the sample will form more antigenantibody complexes which lead to stronger fluorescence signal by detector antibodies, which is processed by the instrument for ichroma™ tests to show CRP concentration in the sample.

COMPONENTS

ichroma™ CRP consists of 'cartridges' and 'detection buffers'.

- The cartridge contains the membrane called a test strip which has anti CRP at the test line, C-reactive protein at the antigen line and streptavidin at the control line. All cartridges are individually sealed in an aluminum foil pouch containing a desiccant, and they are further packaged in a cartridge box.
- The detection buffer contains anti-CRP-fluorescence conjugate, anti- CRP, Biotin-BSA-fluorescence conjugate and sodium azide as a preservative in phosphate buffered saline (PBS). It is pre-dispensed in tubes. The detection buffer tubes are packaged in a detection buffer box and further packed in a styrofoam box with ice-pack for the shipment.



WARNINGS AND PRECAUTIONS

- For in vitro diagnostic use only.
- Follow instructions and procedures described in this 'Instructions for use'.
- Use only fresh samples and avoid direct sunlight.
- Lot numbers of all the test components (cartridge, detection buffer and ID chip) must match each other.
- Do not interchange the test components between different lots or use the test components after the expiration date, either of which might yield incorrect test result(s).
- Do not reuse cartridges or detection buffer tubes. A cartridge should be used for testing one sample only. A detection buffer tube should be used for processing of one sample only.
- The cartridge should remain sealed in its original pouch until just before use. Do not use the cartridge, if pouch is damaged or has already been opened.
- Frozen sample should be thawed only once. For shipping, samples must be packed in accordance with local regulations. Sample with severe hemolysis and/or hyperlipidemia must not be used.
- If test components and/or sample are stored in refrigerator, then allow cartridge, detection buffer and sample to be at room temperature for approximately 30 minutes before use.
- The instrument for ichroma[™] tests may generate slight vibration during use.
- Used cartridges, detection buffers and sample collectors should be handled carefully and discarded by an appropriate method in accordance with relevant local regulations.
- The detection buffer contains sodium azide (NaN₃), and it may cause certain health issues like convulsions, low blood pressure, low heart rate, loss of consciousness, lung injury and respiratory failure. Avoid contact with skin, eyes, and clothing. In case of contact, rinse immediately with running water.
- No Biotin interference was observed in ichroma™ CRP when biotin concentration in the sample was below 3,500 ng/mL. If a patient has been taking biotin at dosage of more than 0.03 mg a day, it is recommended to collect blood again 24 hours after discontinuation of biotin intake.
- ichroma[™] CRP will provide accurate and reliable results subject to the below conditions.
 - ichroma™ CRP should be used only in conjunction with the instrument for ichroma™ tests.
 - Have to use recommended anticoagulant.

Recommended anticoagulant

K₂ EDTA, K₃ EDTA,

Sodium heparin, Lithium heparin, Sodium citrate

- The sample collector should be used when the following conditions are met.
 - The sample collector provided with the kit is recommended to obtain correct test result.
 - Whole blood should be immediately tested after collection.
 - Excess the sample around the sample collector should be wined off
 - In order to avoid cross-contamination, please do not reuse the sample collector for multiple samples.

LIMITATION OF THE TEST SYSTEM

- The test may yield false positive result(s) due to the crossreactions and/or non-specific adhesion of certain sample components to the capture/detector antibodies.
- The test may yield false negative result(s) due to the nonresponsiveness of the antigen to the antibodies which is the most common if the epitope is masked by some unknown components, so therefore not being able to be detected or captured by the antibodies. The instability or degradation of the antigen with time and/or temperature may also cause false negative result as it makes antigen unrecognizable by the antibodies.
- Other factors may interfere with the test and cause erroneous results, such as technical/procedural errors, degradation of the test components/reagents or presence of interfering substances in the test samples.
- Any clinical diagnosis based on the test result must be supported by a comprehensive judgment of the concerned physician in conjunction with clinical symptoms and other relevant test results.

SAMPLE COLLECTION AND PROCESSING

The sample type for ichroma™ CRP is human whole blood/ serum/plasma.

- It is recommended to test the sample within 24 hours after collection
- The sample (serum, plasma) should be separated from the clot by centrifugation within 3 hours after the collection of whole blood.
- The samples (whole blood, serum, plasma) may be stored for a week at 2-8 °C prior to being tested. If testing will be delayed more than a week, samples (serum, plasma) should be frozen at below -20 °C.
- The samples (serum, plasma) stored frozen below -20 °C for 3 months showed no performance difference.
- However, the whole blood sample should not be kept in a freezer in any case.
- As a repeated freeze-thaw cycle may affect the test result, do not refreeze previously frozen samples.
- Whole blood sample may be used to collect according to
 - ① Wear disposable gloves and protective equipment for
 - ② Open the zipper bag which has sample collectors.
 - 3 Take out the sample collector and check for damage or contamination.
 - ④ Touch the surface of blood with the sample collector.
 - ⑤ Fill it with blood completely.

(Make sure that no air bubbles are present in the sample collector. Do not get blood on the surface of the sample collector. If the blood gets on the surface of the sample collector, remove it gently with gauze.)

TEST SETUP

- Check the contents of ichroma™ CRP: Sealed cartridges, detection buffers, sample collectors, an ID chip and an instructions for use.
- Ensure that the lot number of the cartridges matches that of the detection buffers as well as an ID chip.
- If the sealed cartridge and the detection buffer have been stored in a refrigerator, place them on a clean and flat surface at room temperature for at least 30 minutes before
- Turn on the instrument for ichroma™ tests.
- Insert the ID chip into the 'ID chip port'.
- Please refer to the instrument for ichroma™ tests operation manual for complete information and operating instructions.

TEST PROCEDURE

▶ichroma™ Reader, ichroma™ II, ichroma™ M3

Multi test mode

- Make a puncture on the top of a detection buffer by inserting an empty sample collector.
- 2) Take 10 µL of sample (whole blood/serum/plasma/ control) using a sample collector.
- 3) Assemble the sample collector and the detection buffer
- Mix by inverting 10 times or more until the sample is out of the sample collector. The mixture of the buffer

and the sample must be used within 30 seconds.

- Remove the cap off the top of the assembled tube.
 Discard two drops of reagent onto paper towel before applying to a cartridge.
- Load only two drops of the mixture into the sample well of the cartridge.
- Leave the cartridge at room temperature for 3 minutes before inserting the cartridge into the holder.
 - ⚠ <u>Scan the sample-loaded cartridge immediately when</u> the incubation time is over. If not, it will cause inaccurate test result.
- 8) To scan the sample-loaded cartridge, insert it into the cartridge holder of the instrument for ichroma™ tests. Ensure proper orientation of the cartridge before pushing it all the way inside the cartridge holder. An arrow is marked on the cartridge especially for this purpose.
- Press the 'Select' or tap the 'Start' button on the instrument for ichroma[™] tests to start the scanning process.
- (ichroma™ M3 is tested automatically after inserting.)
 10) The instrument for ichroma™ tests will start scanning the sample-loaded cartridge immediately.
- 11) Read the test result on the display screen of the instrument for ichroma™ tests.

Single test mode

- The test procedure is same with "Multi test mode 1) 6)"
- Insert the sample-loaded cartridge into the holder of the instrument for ichroma™ tests. Ensure proper orientation of the cartridge before pushing it all the way inside the cartridge holder. An arrow is marked on the cartridge especially for this purpose.
- Press the 'Select' or tap the 'Start' button on the instrument for ichroma™ tests. (ichroma™ M3 is tested automatically after inserting.)
- The cartridge goes inside the instrument for ichroma™ tests and will automatically start scanning the sampleloaded cartridge after 3 minutes.
- Read the test result on the display screen of the instrument for ichroma™ tests.

▶ ichroma™ III

- 1) The test procedure is same with the 'Single test mode'.
- ▶ ichroma™-50, ichroma™-50 Plus
- 1) Insert the tip array in the tip station.
- Insert the detection buffer tubes in the reagent station and cover the reagent station to hold the detection buffer tubes in place.
- Insert the cartridge magazine with the cartridges into the magazine station.
- Insert the sample tube into the blood collection tube rack and load the blood collection tube rack into the sampling station (loading part).
- 5) Tap the button located in the upper side of the No. of test cartridge region to select the ID chip that you want to use.
- 6) When the selected cartridge slot is activated, set the number of the detection buffer tube by tapping.
- 7) Set the number of pipette tips by tapping.
- 8) Tap the 'Start' button on the left upper of the main screen to start test.

INTERPRETATION OF TEST RESULT

- The instrument for ichroma™ tests calculates the test result automatically and displays CRP concentration of the test sample in terms of mg/L.
- Cut-off value: 10 mg/L
- Working range: 2.5-300 mg/L
- Effect of Hematocrit

The CRP whole blood of the instrument for ichroma™ tests is calibrated to read the CRP serum concentration of a blood sample with a hematocrit of 40%. If the actual hematocrit value deviates from 40%, the result should be corrected by multiplying with the respective factor in the table: deviates from 40%, the result should be corrected by multiplying with the respective factor in the table:





Comparability
